### Part A: Pupil premium strategy plan

#### Statement of intent



Our aim is to support all our students, including those who are disadvantaged, to make excellent academic progress across the curriculum throughout their time at Nailsea School. We are also committed to ensuring that all our students feel included in all aspects of school life and our school community.

We will adopt a whole school approach in which all staff take responsibility for disadvantaged pupils' outcomes and raise expectations of what they can achieve.

The focus of our strategy is to support disadvantaged pupils to achieve that goal, including progress for those who are already high attainers. We will consider the unique challenges faced by pupils and carefully monitor strategies to ensure that we are supporting our students to overcome these challenges.

Our intentions are:

- To ensure that all students receive quality first teaching. High-quality adaptive teaching is at the heart of our approach, with a focus on areas in which disadvantaged pupils require the most support. This is proven to have the greatest impact on closing the disadvantage attainment gap and at the same time will benefit the non-disadvantaged pupils in our school.
- To close the attainment gap between disadvantaged students and their peers. The approach used will be responsive to common challenges and individual needs, rooted in robust diagnostic assessment, not assumptions about the impact of disadvantage.
- To provide targeted academic and pastoral support for students who are not making the expected progress. We will ensure that the impact is monitored and reviewed.
- To address non-academic barriers to attainment such as attendance, behaviour, well-being and cultural capital.
- To ensure that the Pupil Premium Grant reaches the pupils who need it most.

## Challenges

This details the key challenges to achievement that we have identified among our disadvantaged pupils.

Challenge number	Detail of challenge
1	<b>Attendance-</b> Over the last 3 years the figures indicate that attendance among disadvantaged pupils has been lower than for non-disadvantaged pupils. This ranges between 4.7 and 6.6% Absenteeism remains a concern across schools. Assessments show that absenteeism is negatively impacting disadvantaged pupils' progress across all key stages. This is also a challenge for pupils joining the school mid-way through the year who have gaps in their education. From analysis, it is noted that a disproportionate number of these students are often eligible for PPG support.
2	<b>Academic Progress –</b> Assessments, observations and discussion with students indicate that disadvantaged students generally make less academic progress than their peers by the end of KS4. Whilst significant progress has been made since 2019, we aim to narrow this gap further so that attainment is equally strong across all groups.
3	<b>Wellbeing and emotional self-regulation skills</b> Our assessments, discussions and observations have identified that a disproportionate amount of our disadvantaged pupils require support with emotional self-regulation. This



	can be, at times, associated with trauma. This provides a challenge when it comes to planning, monitoring and evaluating their learning. This continues to be a core reason for persistent absenteeism.
4	<b>Financial Equality &amp; Enrichment</b>  Our observations and monitoring suggest many lower attaining disadvantaged students lack opportunities to take part in enrichment activities. This financial inequality has been heightened by the pandemic and could impact on self-esteem, well-being and sense of belonging.

### Intended outcomes

This explains the outcomes we are aiming for **by the end of our current strategy plan**, and how we will measure whether they have been achieved.

Intended outcome	Success criteria
Increase the average attendance of PP students.	Year upon year, we will see:  the overall absence rate for <b>all students</b> being at least in line with national average, and the attendance gap between disadvantaged pupils and their non-disadvantaged peers being reduced to below 4%
To reduce the gap in attainment at KS4 between PP and non-PP students.	Year upon year, our disadvantaged cohort will: score an average Attainment 8 in the top 20% of all schools. gain a neutral or positive P8 score (minimum of 75% of cohort). <b>Due to the pandemic, and lack of prior attainment data, 2025 &amp; 2026 GCSE attainment measurements will be based on Attainment 8.</b>
To reduce the gap in attainment between PP and non-PP students across all year groups.	For all disadvantaged students to make progress in line with, or above, their academic targets. Regular assessment in all subject areas will demonstrate improved attainment and sustained progress for our disadvantaged pupils and a smaller disparity between the scores of disadvantaged pupils and their non-disadvantaged peers. Teachers should also have recognised this improvement through engagement in lessons and book scrutiny.
Improve the emotional self - regulation skills of our disadvantaged pupils.	Observations and student attainment will show that: <ul style="list-style-type: none"><li>• All students will develop a greater awareness of their learning and their personal strengths and weaknesses with a particular process.</li><li>• Students feel more able to regularly attend school and engage with learning.</li><li>• Students will be aware of how they plan, monitor and evaluate their own learning, across all subjects.</li><li>• They are fewer incidents of staff support being called or students leaving lessons.</li></ul>

## Part B: Review of outcomes in the previous academic year

### Pupil Premium Strategy Outcomes

This details the impact that our pupil premium activity had on pupils in the **2024-25** academic year.



The focus on Teaching and Learning, CPD opportunities as well as more robust and consistent assessment processes are now embedded. Due to changing nature of our cohort, we have focused on staff CPD around trauma informed practice as well as adaptive teaching.

Robust and carefully researched teaching and learning strategies have been successfully implemented and we are continuing to review and assure that the impact we have seen is sustained. The embedding of these strategies as well as a continued focus on building positive relationships with our students has to the continuation of the teaching approach of the strategy. Attainment at GCSE supports the positive impact our 'Nailsea Toolkit' of teaching had had.

Whilst whole school attendance sits in line with the National average, missing school will put students at a disadvantage and therefore must continue to be a key part of this strategy. We compare favourably against local trends; however, these gaps are larger than we would like particularly in key groups such as those eligible for support through the Pupil premium Fund. Attendance continues to be a focus of our current plan. We have also seen a rise in the number of students classed as 'persistently absent' and this is being directly addressed through the professional development offered to our mentors, Assistant Heads of House as well as the development of our Hive Alternative provision.

We have worked to try and remove practical barriers such as the cost of specialist equipment or club subs so that all students develop a sense of belonging to our school and wider community. As more activities and enrichment opportunities are introduced, we will continue to focus on supporting all students to access these.
