



# Nailsea School

Dear Parents/Carers

I hope you have all had a chance to rest and recharge, away from a screen, during the recent half term break. As you may have heard from my check ins this week, arriving at work in the light has given a huge lift to my spirits. In addition this week, the announcements (and there have been more than one!) although prompting detailed consideration from us at school, have also indicated optimism for the future.

Although I am outlining some key actions and updates in this week's letter, I would also ask for some understanding that at the time of writing some specific details are yet unknown/not finalised. Please be assured that as soon as I can pass on further details I will do so.

Given the number of announcements this week, this letter does contain a number of details but I hope you find the subheadings useful:

## **Return to School**

The Prime Minister spoke to the nation on Monday and mentioned all children returning to school on 8<sup>th</sup> March. The operational details released by the Department of Education on Tuesday made the FULL opening of schools a real challenge in that timeframe. This is because all students, with consenting parents, and staff have to receive a negative lateral flow test result before returning to face to face lessons and these tests will need to be conducted in schools.

Students are offered three in school lateral flow tests over the first two weeks before being provided with test kits to complete at home. If you have not already completed the consent form please use the link

This form will close on **Sunday 28<sup>th</sup> February at noon** in order for us to finalise the testing schedule. Failure to complete this form by this deadline will mean that in school tests cannot be completed and subsequent home testing kits cannot be issued.

With the government having agreed that schools can begin testing earlier than 8<sup>th</sup> March, specified in guidance on Wednesday, this will mean that most students can return as soon as possible. In order to facilitate a full return to school students will be invited in for tests according to the schedule outlined below. Prior to the 8<sup>th</sup> March students will be invited in for tests and then expected to return home.

Whilst I appreciate this does result in a degree of inconvenience for parents, only by bringing the testing forward in this way can we safely return students to school. If families feel there are any issues with this situation, please contact your son/daughter's Head of Year in the first instance.

Students already booked into the keyworker bubble will continue to attend the provision for wk comm 1<sup>st</sup> March as previously arranged.

Members of staff are also needing to test and there are wider preparations for students returning to school that requires some preparation time. I am also conscious that with testing taking place on certain days for students we would not want to overburden them with a large amount of work to catch up on.

### **Draft Commissioning Strategy**

I have been asked to share North Somerset Council's link to their consultation on Education Provision in North Somerset – A Commissioning Strategy (2021 – 2024)

This is the draft plan for delivering enough school places to enable every child aged 4 – 16 (and those aged 16 – 19 in school sixth forms) to have access to a local school place in the 2021/22, 2022/23 and 2023/24 school years.

The plans needs to meet the needs of a growing population due to new housing in some areas; oversee increases in secondary places due to larger numbers of junior aged pupils and previous residential growth; and manage a potential reduction in demand in other areas due to a fall in birth rates that may affect the numbers of pupils starting school for the first time in areas without significant new residential developments.

As soon as the INSET days have been rearranged we will notify families. Given the changing situation, particularly around assessment this year, we do not want to choose any days that may disadvantage our students.


### **Finally...**
